Decisions on manuscripts will be rendered within 10 weeks of submission. Offers to review books or suggestions of books to review should be sent to the book review editor, Sandra Taylor, Indiana University, Lilly Library, Bloomington, IN 47405.

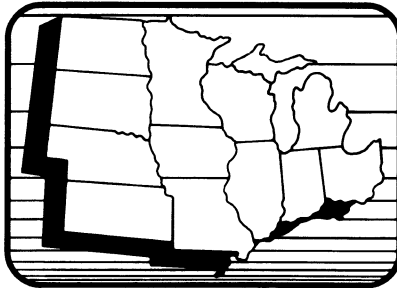
