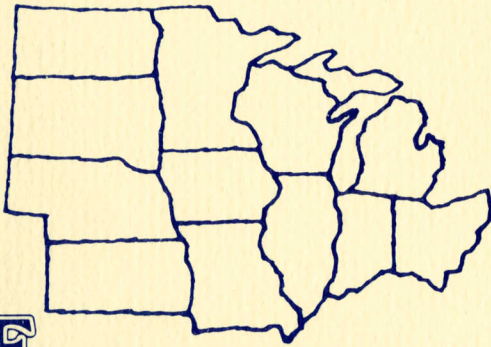

PREFACE

This index provides title, author, and subject entries for all articles and book reviews contained in Volumes 1-8 of the *Midwestern Archivist*. Due to changes in the journal's pagination method, citations to articles and reviews appearing in volumes 1-3 and 8 include volume, issue, and page number, viz., 3(2):27; those appearing in volumes 4-7 are cited by volume and page, viz., 4:84. Page numbers refer to the first page of the article or review.

Complete citations for works by multiple authors appear only under the name of the first author, with "see" references from the names of additional authors.

Entries by title for reviews of repository guides and inventories of records and papers are gathered under the headings, "Guides" and "Inventories," respectively.

Suzanna Moody and Susan Steinwall, both of the University of Minnesota, compiled this index as a voluntary contribution to the Midwest Archives Conference and the archival profession. Ms. Moody, currently a research fellow in Walter Library, previously prepared the index to *Women's History Sources* (R.R. Bowker, 1979). Ms. Steinwall is an archivist at the Social Welfare History Archives. The *Midwestern Archivist* editorial board—itsself a group of volunteers—gratefully acknowledges this extraordinary effort.
